- 2. Retired officials (JCOs/NCOs/Inspectors/Sub-Inspectors/Assistant Sub-Inspectors) from Police, Civil & Military Intelligence Agencies are encouraged to apply for position of Intelligence Officer.
- 3. Candidates proficient in respective regional language shall be preferred.
- 4. Management reserves the right to accept/reject any application and candidate at any stage without assigning any reason.
- 5. Only shortlisted candidates will be called for test/interview.
- 6. Candidate shall be disqualified if false information is provided at any stage.
- 7. 5 years' relaxation in age is already included in above age limit.
